


### NTBA Monthly Update November/December 2021

# Message from NTBA's President, Angelica Rosello



Happy Holidays, Members!

Our annual holiday party was one for the books! This year it was held at Esposito's Italian Restaurant. We had a wonderful time celebrating the holidays and the coming new year together. Jared Krukar, our immediate past President, and I were honored by the NTBA with beautiful engraved clocks commemorating our service as Presidents of the NTBA. We had been unable to celebrate Jared's tenure the year before due to the pandemic and so a double celebration was held at Esposito's. While this gift has been a time-honored tradition to give the outgoing president, I am no less honored and humbled for having had the privilege to receive this award and serve this association. I want to thank you <u>all</u> for helping me to make this year a successful year for our association despite all of the issues that continue from the pandemic. I would especially like to thank our fabulous Executive Administrator, Tiffany Hanson. Without her experience, abilities, work ethic, and devotion to the NTBA, none of what we accomplished this year would be possible.

A look back to where we started this year and how we ended:

#### **CLE Luncheons:**

All of our monthly CLEs for the first half of the year were held via Zoom and we ended the year back to in person with a Zoom option to make sure all our members were provided the opportunity to remain as present and involved as they were comfortable. We continued to have an amazing line up of speakers:

January 2021, Judge Thomas Palermo discussed ethical and effective advocacy in the age of virtual presence technology.

February 2021, Donald A. Smith, Jr. and Debra Davis taught us about trust accounting and how to protect against an audit.

March 2021, family law military divorce expert Kristin Kirkner, Esq. discussed the intersection between military issues and family law.

April 2021, Lance Randall, AFPS & Diana Wardwell, AFPS of the Florida Association of Professional Process Servers explained the ins and outs of service of process.

May 2021, Darrel Dirks, Assistant State Attorney of the 13th Judicial Circuit presented on illegal wiretapping in Florida.

June 2021, we held our first in-person CLE luncheon at the Carrollwood Country Club where Sgt. Duane Benton, Dep. Stephanie Krager, and BHCM Lauren Alston of the Hillsborough County Sheriff's Office discussed the HCSO Behavioral Resources Unit and walked us through how this department assists with mental health and behavioral issues in the community.

July 2021, our in-person CLE luncheons continued with Chief Deputy of the Hillsborough County Property Appraiser's Office Patrick Alesandrini explaining methods of property valuation and the technology Hillsborough County uses to detect improvements on properties and how multiple counties work together to assess property damage from natural disasters.

August 2021, Supervisor of Elections for Hillsborough County, Craig Latimer, discussed the 2020 election and how the county prepares for an election and how they test the voting machines for accuracy. He also examined recent voting legislation and described how and if it will affect future elections.

September 2021, Representative Traci Koster of District 64 provided our members with an in depth legislative update, providing first hand insight about the 2021 Florida legislative session.

October 2021, Judge Mary S. Scriven taught our members about the Supreme Court of Florida's adoption of the federal summary judgment standard, using case studies to address the issue and fielding questions concerning the pleading and the proof required in pursuing and resisting summary judgment under the prevailing standard.

November 2021, we wrapped up our CLEs with Hillsborough County Commissioner Ken Hagan's discussion on Hillsborough County's legislative and policy update.

#### **Socials:**

We held our first social of the year via Zoom with Brewpalooza: a free virtual craft beer tasting, courtesy of the NTBA and Tom and Katie Nealon who served as our host and home brewing experts.

In April, we had our first in-person (outdoor) social. Thanks to our gracious hosts, Bleakley, Bavol, Denman & Grace for offering their beautiful offices and outdoor patio so that we may be able to connect again and network in person while doing so safely.

We held our last social before the holiday party at Glory Days Grill in Carrollwood. A wonderful turnout of members and judiciary made for an incredible evening!

#### **Attorney Roundtables:**

While continuing our monthly attorney roundtables via Zoom at the start of the year, we were able to finally meet outdoor and in person in April. Our roundtables were offered in a hybrid style, both outdoor and in person and via Zoom. In July, we began holding our attorney roundtables in person at one of our favorite local eateries and longtime NTBA sponsor, Brunchies. Our last two attorney roundtables of the year were held at Glory Days Grill in Carrollwood.

#### The Board:


